#### 1. Declaration of Quorum

1.1 The President of the Council 2021/2023, Ms Koh Juat Muay (on behalf of the Honorary Secretary), convened the Annual General Meeting (AGM) at 6.30 pm. The call for quorum was as follows:

As there was no quorum, the meeting was adjourned to 7.00 pm in accordance with the Constitution.

1.2 The Honorary Secretary, Ms Juliet Samraj, reconvened the AGM at 7.00 pm. The AGM was then called to order by President, IPRS, Ms Koh Juat Muay.

#### 2. Adoption of Minutes of the 52<sup>nd</sup> AGM that was held on 30 March 2022

- Errors identified in the minutes of the 52<sup>nd</sup> AGM will be amended. This includes:
  - In-person attendance numbers of the 51st AGM to be amended to 17
  - 7. Adoption of the Financial Report 2021 With no further questions, the Hon Secretary called for a voting member to propose that the Financial Statement for 2021 be adopted. The adoption of the Financial Statement Report 2021 was proposed by Accredited Member, Mr Clarence Fu, and seconded by Accredited Member, Ms K Bhavani
  - 9. Closing As there were no other questions, the Hon Secretary, Ms Juliet Samraj, thanked all Members for their presence and called the 52<sup>nd</sup> AGM to a close at about 8.15 pm.
- No further queries or objections were raised. The Minutes of the 52<sup>nd</sup> AGM were adopted. 2.2 The motion was proposed by Full Member, Ms Gerardine Donough-Tan, and seconded by Accredited Member, Ms Kathy O'Brien, both of whom were present at the 52<sup>nd</sup> AGM.

#### 3. Matters Arising

Over the course of 2021 and 2022, the IPRS has explored the issue of membership fee revision. The President, Ms Koh Juat Muay, explained that the Institute's membership fees are one of the most accessible in the market. It has been more than 10 years since the last revision and it is an opportune time to consider adjustments. The Council Members have looked into this matter and proposed the following changes:

President, Ms Koh Juat Muay, informed that these changes must first be approved at the AGM before being submitted to the Registry of Societies (RoS) for their approval under Amendment of Rules, a process which is expected to take around 2 months. The new membership fees will be effective after approval by the RoS is received.

- 3.1.1 Full Member Ms Gerardine Donough-Tan asked why the proposed subscription fee for Associate Members would be raised to \$95 and not \$100. President Koh Juat Muay explained that Associate Members tend to be new to the industry and so keeping it at \$95 would better attract them to joining the IPRS as a member.
- 3.1.2 Full Member Lars Voedisch remarked that the percentage increases (for Full Members, against the current rate) of 20% in 2023 and 50% in 2024 seem steep and wondered if the RoS would consider that in their review. He suggested that the Institute could indicate in its RoS submission the reasons for the increases such as the increase in operating costs and its benchmarking against other similar societies. He also asked if this increase in fees would make an impact on the IPRS' revenue. President Koh Juat Muay acknowledged that although costs have increased the IPRS has also taken much steps to keep this to a minimum. The increase in fees reflects the efforts put into digitalising and modernising the IPRS through its new membership portal and engagement activities. It is hoped that the incremental adjustments in phases from \$120 then to \$150 would mitigate the financial impact this will have on Full Members. President Koh Juat Muay was grateful for this feedback and the IPRS would respond accordingly if questioned by the RoS.
- 3.1.3 Accredited Member Eric Chan feels that the increases are reasonable and justified against the increased costs in the operating environment today. President Koh Juat Muay agreed that this revision conveys the appropriate message that membership in the IPRS is valuable and worth the increase.

3.1.4 President Koh Juat Muay shared details of items "Entrance Fee" and "Subscriptions" in the Constitution to be submitted to the RoS for approval of membership fees revision, under Amendment of Rules. Members agreed to proceed with this submission for Amendment of Rules.

3.1.5 Accredited Member Ms K Bhavani asked if there would be any changes to the number of attendees from Corporate Members at events or any additional benefits for them, on the back of these fee revisions. President Koh Juat Muay explained that Corporate Members are allowed to send up to 5 attendees per event, but that the Institute would not forcefully limit this as most Corporate Members participate in events as sponsors. However, a limit may need to be considered on the number of attendees attending training programmes at a discounted rate as this may impact

revenue. A limit of 8 attendees per Corporate Member per training program may need to be mooted at a separate session.

The Meeting then proceeded with the presentation of the President's Report.

#### 4. President's Address

- 4.1 The President of the Council 2021/2023, Ms Koh Juat Muay informed that the 2022 Annual Report which highlighted the Institute's performance in 2022 is available on the website. Key milestones include digitalisation efforts and migration to a new cloud-based membership portal, moving out from a physical office location, organising numerous events for the Student Chapters and holding the inaugural IPRS PRISM Summit which met with positive feedback. These would not have been possible without the assistance and support of the Council Members, Institute Members as well as members of the community and industry at large.
- 4.2 President Koh Juat Muay shared that four main (CORE) pillars anchored the Institute in 2021/2023. The Council, as a seat of professional influence, should attract the best people to take the Institute forward. Operations of the Institute is a key element, and the Council has endeavoured to ensure efficiency and effectiveness across its various functions from membership, administration, finance to event management. The importance of Relationships cannot be underscored, which has allowed the Institute to engage and collaborate with larger and stronger institutions. This has allowed the Institute to have an Effect on the industry drawing attention to the profession and gaining respect for what its Members do.

#### 5. Adoption of the Annual Report and Financial Report 2022

- 5.1 The Honorary Treasurer, Ms Cindy Lim, presented the Financial Report 2022.
- As of FY2022, IPRS Cash and Cash Equivalent stands at \$143,696. Total Equity and Liabilities for FY2022 stands at \$175,940. This represents a 5% increase from \$167,336 in FY2021. This indicates a healthy situation as Total Equity and Liabilities fell during the COVID period but FY2022's performance indicates a reversal of this decline.
- 5.3 Revenue for FY2022 stands at \$115,426, almost equivalent to FY2021. Gross profit stands at \$76,214. This is also similar to the FY2021's level of gross profit. Income sources in FY2022 are largely similar to those of FY2021's 42.3% from training, 24.7% from sponsorship (of PRISM and the membership portal), 19.4% from membership / entrance fees and 13.5% from the PRISM Summit. Training income represented a 57% growth from FY2021 and Programme/PRISM Summit income which was not collected in FY2021 could be collected in FY2022.
- 5.4 Operating expenses stands at \$126,110, a 14.5% decline from \$147,649 in FY2021. The biggest expense items were Salaries (59%) and Rental (11%). Compared against FY2021, salaries

have decreased by 33%, and rent has decreased by 30%, a positive outcome arising from moving out of the office premises into a co-working and hotdesking facility in August 2022. Loss before tax is at \$8,359, compared against \$56,404 in FY2021.

- 5.5 Accredited Member Mr Eric Chan congratulated the Council on a fantastic balance sheet. Full Member Lars Voedisch also commended the Council on turning the financials of the Institute around despite worrying trends during previous FYs. Accredited Member K Bhavani congratulated the Council on the decision and effort to move out from a physical location onto a co-working space. To these remarks, President Koh Juat Muay thanked the past Presidents who contributed to the procurement of the membership management portal licence through donations to the President's Circle Fund. Special mention was made to recognize and thank the immense efforts of Secretariat Ernst Lim for clearing out the stores at the office. Acknowledgement was also given to R Selvi who mooted and encouraged the digital transformation of the IPRS and to move out of a physical office space.
- 5.6 Adoption of the Annual Report and Financial Report 2022
  With no further questions, the President called for a voting member to propose that the Annual Report and Financial Statement for 2022 be adopted. The adoption of the Annual Report and Honorary Treasurer's Financial Report 2022 was proposed by Accredited Member, Mr Eric Chan, and seconded by Fellow, Mr Ken Hickson.

#### 6. Election of Council 2023/2025

- The President of the Council 2021/2023 then announced the dissolution of the Council 2021/2023.
- 6.2 The floor was then handed over to Accredited Member, Ms Kathy O'Brien, the Returning Officer (RO), to conduct the election of office-bearers for IPRS Council Term 2023/2025.
- 6.3 The RO announced that voting members were invited for nominations for the positions of President, Vice-President, Honorary Secretary, Honorary Treasurer and Council Members (minimum five, maximum seven). The closing date was 5pm, 1 March 2022.
- 6.4 The RO announced that at the close of the deadline for nominations, ten nominations, duly signed and seconded, for the positions of President, Vice-President, Honorary Secretary and Seven Council Members, had been received. The nominations were as follows:

- 6.6 As there were no nominations for the position of Honorary Treasurer, the newly elected Council will appoint a Council Member to the position.
- 6.7 Incoming President, Ms Koh Juat Muay, then introduced the Members of Council 2023/2025.

#### 7. Any Other Business

- 7.1 The President then opened the floor for questions or comments. Fellow Ken Hickson complimented the PRISM Summit for setting high standards for the profession, reinforced the importance of relationships such as connecting with the Singapore Institute of Directors, as well as recognizing the formation of new connections with organisations such as Telum Media. He was also glad that mature members of the Institute are still present and engaged. President Koh Juat Muay also expressed appreciation to new and young members who joined the Institute and the Council.
- 7.2 Accredited Member Kathy O'Brien proposed that the Council be congratulated for a very commendable job and recognize the values and work ethics of President Koh Juat Muay.
- 7.3 President Koh Juat Muay mooted the idea of an industry veteran's night to reconnect with valuable expertise and knowledge holders in the industry and re-engage them.

#### 8. Closing

As there were no other questions, the Honorary Secretary, Ms Juliet Samraj, thanked all Members for their presence and called the 53<sup>rd</sup> AGM to a close at about 8.00 pm.

### PRESIDENT'S REPORT

Warmest greetings on behalf of the IPRS Council 2023/25.

The year 2023 began with the election of the Council for 2023/25 at the 53rd Annual General Meeting. My heartfelt thanks to Vanessa Wan, Cindy Lim and Selvi R for remaining on the Council for another term to continue our work on the transformation of the IPRS and ensure a smooth transition to a new Council Team. My deep thanks to Haikal Fahim, Elaine Chan, Marcus Ong, Jini Pillai and Malminderjit Singh for agreeing to step forward to serve the IPRS. Together this new Team of 10 embodied a diversity of background, experience and knowledge to take the IPRS to new heights.

The office bearers in the Executive Committee - the President, the Vice-President, Hon Secretary and Hon Treasurer carried out their responsibility of providing effective oversight to the IPRS Secretariat to ensure timely payments to staff, suppliers, and the secure management of our membership and financial systems.

The mandate and manifesto for 2023 was to put our People and the Profession front and centre of IPRS' programming to support the professional development of practitioners and raise the profile of the contributions to the communications success of their organisations and clients. This mandate included the nurturing of our next generation of PR people in our 10 Student Chapters.

The year saw Generative AI dominate conversations beyond the tech world as its impact on the future of work was felt across professional sectors. Content generation became supercharged with AI programmes like ChatGPT, Midjourney and DALL-E. While many began riding the tide of GenAI, many also defaulted to putting distance between themselves and technology. It was important nonetheless to stay abreast and prepare our sector for a tech-fueled world. The IPRS held two tech discussion events and launched the AI Guidance for PR And Communications Professionals, a free resource and best practice reference for the industry.

It was heartening to see a strong uptake in demand for IPRS training in 2023 and receive record submissions for the IPRS PRISM Awards 2023, signaling a clear recovery from the pandemic years.

A test of this economic resilience came in the form of volatile geopolitical events in Europe, the Middle East, US and closer to home in South East Asia that jolted economic stability and global supply chains.

Since its inception in 1970, the IPRS has witnessed several global recessions and financial crises. It continued its mission to this day. Taking IPRS fully online in 2023, the Council has helped the institute to reduce costs and increase efficiency and capacity to organise purposeful events; to adapt to an increasingly digital world

The improvement of our membership system needed the support of members. One significant note is the agreement by members to the revision/increase of membership fees at the 53rd AGM. The amendment to the Constitution for this adjustment was approved by the Registrar of Society in July and duly adopted.

2023 welcomed new members to the IPRS and saw the return of members who were inactive during the pandemic. Corporate support for IPRS events increased along with partnership activities.

The IPRS was invited to deliver the Welcome Address at The Indie Summit 2023 held in Singapore. It was an event to celebrate independent agencies from around the world; a platform for the IPRS to contribute to the global presence and share the unique success of the Singapore brand.

As a professional body, the IPRS is the bearer of standards and performs this role across the public, private and social sectors. The industry's strong support for the IPRS PRISM Awards 2023 is testament to the recognition of this role.

We owe the success of 2023 to IPRS Members, friends in the industry and the business community for believing in the value that PR and communications bring to people and organisations.

I commend the Council Members of 2023/25. Details of the year's efforts are in the individual portfolio reports by the Vice-President, Hon Secretary, Hon Treasurer, Membership, Training, Student Chapter and Accreditation Teams.

We look forward to 2024.

### HONORARY SECRETARY'S REPORT

In 2023 the IPRS organised and participated in 24 events/training programmes, reaching out to over 500 participants, in person and online. The year started with the IPRS Annual Student Chapter Gathering held in February which was attended by over 40 student chapter advisors and members. Other notable events include our new Learning Luncheon online series, 'How 100 Singapore Companies approached Purpose', as well as the 'IPRS x CARMA Asia Forum: Rewriting the Rules of PR Measurement'.

The IPRS was invited to give the Opening Address at a global event, The Indie Summit 2023 held in Singapore. The IPRS was also active in Singapore's charity sector, participating in two key events: the Shared Services Annual Seminar 2023 and the Charity Council Conference 2023.

In November, our members engaged in robust conversations around Generative AI and its impact on PR through two IPRS events: 'The Debate: Generative AI – Boon or Bane? (in person), and launch of the 'AI Guidance for PR & Communications Professionals' (online) following a corresponding survey, the "PR Industry AI Protocol Survey" launched in July.

Our appreciation to Vice President, Vanessa Wan, who represented the IPRS on the Supervisory Board for Rothman & Roman Employee Communication Trend Report on Responsibility and Sustainability at The Workplace. The Report studied best practices in employee engagement in Singapore and the region, with the aim to facilitate knowledge sharing and inspire those working in communications and HR. The Report will be published in early 2024.

President Koh Juat Muay was invited to comment on the white paper report on "Marcom in Asia: Optimism and opportunities,' by the Aspectus Group that explores key insights shared by PR, marketing, and branding professionals overseeing the APAC region.

The biggest highlight of 2023 was the IPRS PRISM Awards in November, held at the Parkroyal Collection Marina Bay with over 170 guests in attendance. The gala luncheon was graced by Guest-of-Honour, Mr Tan Kiat How, Senior Minister of State for Communications and Information. IPRS received a record-breaking 121 award submissions spanning 26 categories from 47 organisations. This year's edition shines the light on People in PR – professionals, teams and champions who have made an impact through their mastery of PR strategy and execution skills.

Together with Council Members, the IPRS Secretariat supported the strategy and execution of the many IPRS activities in 2023. Since 2022, the IPRS website and membership platform has transitioned to the cloud-based platform Glue-Up, following a successful digital transformation journey to automate processes.





2. Total Equity and Liabilities for FY2023 stands at \$178,911. This represents a 2% increase from \$175,940 in FY2022. To facilitate benchmarking against Covid financial performance, a four-year comparison, including FY2020, is provided below.




#### As of FY2023, IPRS Cash and Cash Equivalent stands at \$163,774.

3. Revenue for FY2023 stands at \$136,327. This represents a 15% increase from \$115,426 in FY2022. Gross profit stands at \$83,040.



#### 3.1 <u>Income</u>

For FY2023, IPRS income sources were from: Training (39.6%), Sponsorship [PRISM Awards only] (16.4%), Membership/Entrance fees (18.1%) and Programmes (25.8%).




In comparison to income earned in FY 2022:

- Income from programmes (PRISM awards) increased by 51% (\$21,421).
- Membership income decreased slightly by 0.6% (\$170).
- Training income decreased slightly by 0.5% (\$350).
- Sponsorship from PRISM Events saw a large increase: \$26,800 (Awards FY 2023) vs \$19,600 (Summit FY 2022).



#### 3.2 Expenses



**Operating expenses** stands at \$91,168 a 38% decline from \$126,134 in FY2022. The biggest expense items were Salaries (54%), Accounting/Audit Fees (24%) and Rental (9%). Compared to FY2022, salaries have decreased by (16%), Accounting/Audit Fees decrease by (2%) and rent has decreased by (68%). A positive outcome arising from moving out of the office premises into a hotdesking facility in August 2022.

Profit before tax is at \$20,080, compared against loss \$8,359 in FY2022.

#### 4. Outlook & Recommendations

- Overall, at the end of FY2023, the IPRS' financial position has improved posting a profit before tax of \$20,080 as a result of the digitisation of its membership system, salary and rental savings. This is after a low net loss of \$8,359 in FY2022 and high net loss in \$56,404 in FY2021.
- 4.2 In order for the IPRS to be sustainable and relevant in the years ahead, IPRS needs to build on its flagship events, the PRISM Awards and PRISM Summit to attract new sponsors and partners. IPRS is also well-positioned to develop joint partnership events to raise its profile to engage existing members and attract new members. As a recognised training provider, there is potential for IPRS to leverage on its signature training programmes adding to this portfolio other programmes such as PR leadership programmes.
- 4.3 The viability and sustainability of the IPRS is an ongoing challenge and rests on the support of its members and the wider industry and institutional partners..

### MEMBERSHIP TEAM'S REPORT

IPRS memberships across the five paying categories (Accredited, Corporate, Full, Associate and Affiliate) remained largely consistent in 2023. This steadiness is a reflection of our position as Singapore's professional body for PR practitioners and PR consultancies.

In reflection of our position and the need to meet increasing operational costs, the IPRS Council 2021/ 2023 proposed a tiered increase to fees over the next two years to ease the cost burden on members. The proposal was raised and accepted during the 53rd Annual General Meeting and was approved by the Registrar of Societies in July 2023.

In addition, IPRS continued efforts to tap into a larger part of the communications industry in Singapore that has eschewed IPRS membership over the years. This includes maintaining visibility within the industry, marketing efforts to reach out to a wider contact base and upholding our commitment to nurturing PR students in our tertiary institutions.

A membership drive, leveraging the marketing efforts for the PRISM Awards, yielded promising results in membership growth and garnering new interest from potential members.

#### Membership

We continue to see moderate growth in membership figures and were delighted to welcome a total of 25 new memberships: 5 Corporate Members, 2 Accredited Members, 11 Full Members, 5 Associate Members, and 1 Affiliate Member in the past year. In addition, about 37 students have applied and became Student Members as part of our various Student Chapter arrangements.



### TRAINING TEAM'S REPORT

IPRS' training programme has gone from strength to strength, building upon the growing positive reputation of the Institute and its trainers. We remain focused on providing a solid foundation of knowledge and ground expertise for PR practitioners who wish to upgrade their skills, and for those aspiring to join the communications industry.

In 2023, IPRS conducted 1 intake of the Professional Certificate in PR and Mass Communication; 3 intakes of Introduction to PR and Mass Communication. A total of 46 participants were trained, including 11 overseas participants from Hong Kong.

We are grateful to our slate of trainers who continue to support the IPRS in our mission to promote excellence in the industry through education that is aligned with the changes and developments in the practice of PR and communications. We are constantly reviewing the quality of our training content and trainer's capability, monitoring these closely via feedback and in-class delivery. Training also has also been reviewing the collaboration agreement with SSA Academy, in particular making improvements in marketing efforts in the next year.

#### Looking Ahead

In addition to developing members and non-members as communications professionals, training and speaking at webinars are also a platform and opportunity for Accredited and Full Members to build their training/speaking skills and to give back to the profession. We encourage more Members to offer themselves for such opportunities, as we look to widen and diversify our pool of trainers and speakers.

Recognising the different needs of communications practitioners at different stages of their career. we have begun work to develop two additional courses which we hope to be able to launch in the second half of 2024. One is aimed at young practitioners which will include fireside chats and networking sessions to enable them to gain insights not available in a traditional classroom setting the IPRS Young PR Leadership Programme.

The other course is for those at the mid to senior levels, who desire to successfully transition into senior leadership roles. The coursework will be less about the technical skills of PR, and more about the higher order thinking and soft skills needed to be at the C-Suite. Mentoring by a senior practitioner will be an important element in this course - the IPRS PR Leadership Programme.

We are encouraged by the strong support for IPRS training and hope to continue teaching the foundations of good PR and Communications and more importantly to build strong practitioners in leadership roles who deliver excellent work in their career.

Provide context and clarity upfront on the focus of the programme, whether tailoring it to PR professionals within an agency or in-house practitioners from specific industries, to ensure attendees adopt the right application of the knowledge gained.

### **IPRS PRISM Awards 2023**

The IPRS held its biennial PRISM Awards on 29 November at the PARKROYAL COLLECTION Marina Bay, with over 170 guests in attendance. Celebrating the very best in public relations and communications, the gala luncheon was graced once again by Guest-of-Honour. Mr Tan Kiat How. Senior Minister of State for Communications and Information.

This year's edition shone the light on People in PR – professionals, teams and champions who have made an impact through their mastery of PR strategy and execution skills. The IPRS conferred the Lifetime PR Achievement Award to well-known industry veteran, Jennifer Lewis. Singlife's Pearlyn Phau bested several others to be named Outstanding PR Champion. Some of the other People awards given out were Outstanding PR Leader, Outstanding Young PR Professional and Outstanding PR Student, amongst others.

Other notable winners were Singtel for PR Campaign of the Year, also receiving a Distinction Award for Outstanding Employee Engagement Programme. Grayling emerged as the winner of the hotly contested Outstanding 360-degree Integrated Campaign – Consumer category.

In the popular Outstanding Sustainability Communications Campaign category, Redhill and The Hoffman Agency emerged as the winners. Other highlights include TOUCH Community Services which won Outstanding Campaign by a NGO or NPO, and The Hoffman Agency's campaign "Hearing Partners encourages Singaporeans to #ListenAgain" which took the Distinction award for Best Use of Storytelling.

A total of 121 submissions were received, an almost 30% increase from the Awards in 2021. These were submissions from 47 organisations across 30 award categories. 53 awards were given out this year, including 17 Distinctions, 23 Merits and 13 Individual Awards.

The distinguished panel of 41 judges comprised senior PR and Communication practitioners, leading PR and Communication academics, senior media representatives, professionals, business leaders and IPRS Council Members.
